At Australian Communities Foundation, we help people and organisations make a difference through structured giving, also known as philanthropy.

Structured giving uses a vehicle such as a public ancillary fund (like our Foundation), private foundation, bequest or legacy trust to help you take control of your giving.

This enables you to target your giving over the long term to make a positive impact on the issues that matter most to you.

As a community foundation, we bring together givers from all walks of life. Community foundations are the fastest growing form of philanthropy around the world – and there's good reason.

Community foundations are independent, not-for-profit organisations that help build and strengthen communities through giving. Rather than supporting any single cause, community foundations help people invest in the causes they care about.

3. Create a lasting legacy

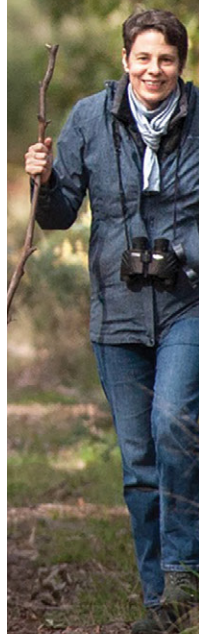

EFFECTIVE OPTIONS FOR FAMILIES + INDIVIDUALS



Named Funds OR DONOR-ADVISED FUNDS

Establishing a Named Fund is an easy, tax-effective and strategic way to support the causes you care about.

When you open a Named Fund with us, we take care of the administration and compliance, leaving you free to focus on the joy of giving.

Grants can be made from your Named Fund at any time to the charitable organisations of your choice.

You can make additional donations at any time, invite others to contribute through our online Donations Portal, and undertake fundraising activities using our nationwide licences.

Donations into your Named Fund are 100 per cent responsibly invested.

Private Foundations OR PRIVATE ANCILLARY FUNDS

For those looking to enjoy the benefits of a community foundation while retaining the independence of their own foundation, we can support you to set up a Private Foundation.

A Private Foundation (otherwise known as a private ancillary fund or PAF) can be an attractive option for anyone who wants to be actively involved in the governance of their giving vehicle, including investment management.

In addition to support with establishment, we provide ongoing assistance through ACF Advisory – see pg. 11.

SPOTLIGHT: FAMILY FUND

Melbourne-based donors Anne Thompson and Paul O'Shea are passionate about social justice with a long history of volunteering.

Anne and Paul support a range of causes and organisations through their Named Fund, ranging from large national charities, such as The Smith Family, to smaller not-for-profit organisations like Melbourne's Woor-Dungin, a not-for-profit that connects Aboriginal-led organisations with philanthropic partners. Anne and Paul believe more Australians could be involved in "really rewarding" philanthropy.

"Australian Communities Foundation does a fantastic job of putting structure around our giving, keeping us informed and doing a lot of the backroom work. And then you do get satisfaction because the causes that they bring to our attention really hit the spot as far as we're concerned."

SPOTLIGHT: PRIVATE FOUNDATION

Onidine Spitzer and Hugh Belfrage are on an ambitious giving journey to alleviate the housing affordability and accessibility crisis in Australia.

Using Australian Communities Foundation's experience and expertise, Onidine and Hugh recently established the V&F Housing Enterprise Foundation. Hugh and Onidine agreed early on that targeting a single, fundamental issue in a structured way with their giving was preferable to making ad hoc donations to a range of causes. After researching different philanthropic structures, the pair opted to establish a private ancillary fund.

"Australian Communities Foundation helped us set everything up administratively and legally – it's been a very positive experience," Onidine says. "We came back to the Foundation to talk about getting regular and ongoing support to help set us on our way and that's been instrumental to getting us where we are."





Other Funds tailored to your needs



Corporate and Workplace Funds

Corporate and Workplace Funds enable organisations across Australia to establish and extend their giving programs.

When you open a Corporate Fund with us, whether it is for your company or employees or both, you can start giving without the administrative burden on internal resources. All funds are responsibly invested, and our team can support you to give in line with your organisation's mission and values. Note: Private Foundations are also available to organisations.

SPOTLIGHT: CORPORATE FUNDS

Melbourne-based management consulting firm Nation Partners established a Corporate Fund to extend its existing giving program. "We were at a point in our giving journey where we felt we were ready to bring some structure and strategy to how these resources are used in the future," says Managing Director, Matthew Nation.



Collective Giving Funds

Collective Giving Funds support like-minded groups and giving circles to pool their donations and give together for collective impact.

We take care of all granting administration and compliance, allowing you to focus on the joy of giving together. Our two-week granting cycle means you can distribute grants quickly and responsively. Whether you are holding a fundraising event or seeking payment of recurring membership fees, our online donation services provide quick and easy solutions.

SPOTLIGHT: COLLECTIVE GIVING

Groundswell is Australia's first giving circle dedicated to funding strategic, high-impact climate advocacy and action. "The real power of being part of a giving circle is that we're stronger together," says Groundswell co-founder Clare Ainsworth Herschell. "When you walk that journey in a community it takes away a bit of that overwhelm."

NAMED FUNDS FOR ALL GIVERS

In addition to supporting families and individuals to structure their giving with a Fund or Foundation, we also offer a range of tailored Named Funds.



Future Funds

Future Funds are a low-cost way for not-for-profit organisations to build an endowment for their long-term sustainability.

You gain access to our fundraising and donation infrastructure, and can enjoy investment returns through our pooled ethical investments. Future Funds are also available to individuals, families and other groups looking to support a single organisation.

SPOTLIGHT: FUTURE FUNDS

Regional Arts Australia works across all states and territories and all art forms. The organisation uses a Future Fund to fundraise and increase its core capacity. Scholarship Funds

Scholarship Funds support people to provide payments that give others greater access to education.

When you open a Scholarship Fund, you have the choice of providing educational payments, prizes and bursaries to scholarship-providing charities or directly to students. You can choose an existing scholarship to support or engage our team to assist in designing your own, including its purpose and selection criteria.

SPOTLIGHT: SCHOLARSHIP FUNDS

When Sydney barrister Joanna Knight passed away at just 36 years old, her family and colleagues established a scholarship in honour of her dedication to social justice. With support from Australian Communities Foundation, the Scholarship Fund is now helping people from diverse backgrounds begin their careers in law.

*** No minimum distribution requirements for individual funds. As a public ancillary fund, Australian Communities Foundation must distribute 4% of the opening value of its corpus each year. This is calculated at the consolidated trust fund level, giving you flexibility as needed.



Just getting started on your giving journey? Grow a Named Fund with a Gumnut Account

Establishing a Gumnut Account is an easy way to start your journey towards structured giving.

Simply open an account and make regular, tax-deductible donations to build a charitable fund. With the option of quarterly or annual contributions, you can get started with as little as \$500 per quarter or \$2,000 per annum, and you'll gain access to all the benefits of our giving community.

Like a Named Fund, donations to your Gumnut are responsibly invested, meaning your money can grow and benefit communities while it waits to be granted out. Once your balance reaches \$10,000, your Gumnut matures into a Named Fund and you can start granting.

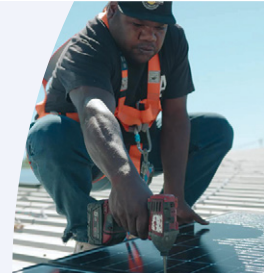

Here's a snapshot of some of the biggest wins our Impact Fund community has contributed to over the last five years:

- ✓ Australia's first coalition for gun safety established
- ✓ Marriage equality achieved for all Australians

- ✓ Over \$800 million in government funding secured to support 80 Indigenous ranger groups
- ✓ 191 refugees and people seeking asylum brought to Australia from offshore detention to access urgent medical care
- ✓ Public drunkenness laws that discriminate against Indigenous people decriminalised in Victoria
- ✓ Climate inaction by governments recognised as human rights violation in historic Torres Strait Eight case
- ✓ Abortion decriminalised in QLD and NSW, and safe access zone laws defended in VIC and TAS
- ✓ Divisive Religious Discrimination Bill that would have wound back anti-discrimination laws shelved indefinitely

SPOTLIGHT: LEAVING A LEGACY

Writer and academic Dennis Altman recently chose to leave a gift to his Named Fund at Australian Communities Foundation – a decision he made for two reasons.

“First, knowing that it will be invested and grown into an ongoing source of funding for my focus areas makes it a more attractive option than simply leaving a one-off gift to charity,” says Dennis.

“Secondly, one of the things I’ve learnt about good philanthropy is that it should actually aim to have itself replaced. If you’re funding a program and it’s really good, then I think the state should start funding it. There’s been a number I’ve seen that have been successful in this sense. So perhaps the projects I’m funding today won’t need funding tomorrow.

“Knowing that the Foundation will be there to identify new projects aligned with my interests reassures me that I can contribute to progress for future generations.”
